



LIFETIME LIMITED WARRANTY

Haskins Automotive performs all repairs in accordance to I-CAR Procedures and your Vehicle's Manufacturer Repair Standards and Specifications. This warranty guarantees the work performed by Haskins Automotive so long as said vehicle remains under the present ownership and shall only apply if the defects occurred under normal driving conditions and not where any vehicle has been subjected to accidents, negligence, abuse, or misuse. Specifically excluded from this limited warranty is rust through metal scratches, gravel or rock chips to painted panels and cracked paint on flexible parts resulting from impact. Items on the repair order such as Sublet Work or Sublet Labor are subject to the guarantee of those vendors. Specific additional stipulations pertain to the following six parts of our limited warranty:

METAL WORK: Haskins Automotive provides a Lifetime Warranty against defective workmanship to include the application of materials utilized in performing collision damage repairs to previously discretion, repair and repaint any metalwork as warranted.

STRUCTURAL WORK: Haskins Automotive provides a Lifetime Warranty against defective workmanship which includes the measuring, repositioning, welding or bonding during the repair or replacement of structural panels of your vehicle, against cracking, flaking or deterioration. This shop will, at its sole option and discretion, repair or replace and repaint any structural work as warranted.

PAINTING: Haskins Automotive provides a Lifetime Written Warranty on all parts and panels that were refinished by us against solvent blistering, fading, hazing or flaking, excluding defects which are caused by extreme environmental conditions to which the vehicle may have been exposed to. This shop will, at its sole option and discretion, repair, reprime, and repaint any affected area. Our paint warranty is valid only when applied over the original factory finish or any finish previously applied by us. We cannot be responsible for any paint under ours.

PARTS: Haskins Automotive guarantees that parts and materials used by us are of top quality. Those parts or materials are subject to the guarantee of their supplier. We will assist you in handling any claim under the supplier's guarantee. We will guarantee OEM parts for 2 years. Used parts (LKQ) or parts other than Original Equipment Manufacturer parts are often referred to as Aftermarket Parts or Quality Replacement Parts (QRP) that were mandated by your insurer in accordance with your insurance policy and Massachusetts state insurance regulations are guaranteed along with the installation labor and refinishing of the part, if applicable, for one year.

MECHANICAL REPAIRS: Haskins Automotive provides a 1-year Warranty on all mechanical repairs that were performed by us and appearing specifically on your repair order. This shop will, as its sole option, re-repair any mechanical assembly or component as warranted. If subsequent issues arise pertaining directly from the original collision damage, we will assist you in getting reimbursement from the responsible insurance carrier.

STRIPES AND DECALS: Haskins Automotive provides a 2-year Warranty on the application and adhesion of decorative stripes and decals. We will re-stripe or re-decal the specific section of the vehicle as warranted.

Specifically excluded are incidental costs, such as towing fees, car rental charges, travel expense, or assemblies and components which were not specifically repaired or replaced during this repair. This written warranty shall not be varied, supplemented, qualified, or interpreted by any prior course of dealings.

This written Warranty shall be null and void, if the repair is altered, adjusted, or tampered with by any person not authorized by Haskins Automotive. This warranty is not transferable.
